

The textbook definition

"A policy is a statement of intended direction developed to guide future actions and decisions. A policy statement may deal with any level of decision or action from high-level strategic directions to task-specific administrative procedures."


Looking inside: the different players



Who does what? Division of powers


Federal, provincial, and municipal governments play different roles in our system. Some of this is spelled out in our constitution.








The policy-making process (on paper)



- 1. Who do you need to influence?
- 2. What are you trying to change?
- 3. Where are the best points of intervention?
- 4. When do you fit into the policy development process?
- 5. Why do you see your organization playing a role?



Importance of communication

- Connecting to government priorities
- Giving them the information they need to make decisions

Understand your assets

- Knowledge of the issue
- Connection to the community
